Cheney, Washington, April 22, 15.

A Meeting of the Board of Trustees was called to meet at Hotel Hotel Spokane at 12 o'clock M. Those present Mrs. Monroe, Mr. MacLean, Mr. Tustin and Mr. Showalter.

After considering all the bids for lockers for the Gymnasium, the contract was awarded to John W. Graham & Co., who was the lowest bidder. The price is \$3.47 each installed in building.

Mr. Showalter was authorized to purchase a Peerless Moving Picture Machine together with the necessary apparatus for installation and full equipment of same.

Mr. Showalter was authorized to contract with Thomas McGart for the installation of the gas plant in connection with the new Administration Building of the State Normal School. The contract was awarded upon the bid herewith attached and becomes a part of the minutes.

The regular monthly meeting was arranged for Wednesday, April 28th instead of Saturday the 24th on account of some members finding it impossible to attend on Saturday afternoon.

Meeting adjourned at 1:30 P.M.

Complying with your verbal request for prices on gas plant wish to state that prices are as follows:-

These prices are as near as it is possible to figure them with the exceptions of the labor and also the pipe and fittings to make connections with the 110 or 115 outlets, which may be possibly a little more or a little less, but the prices for all the other material that comes from the factory I can guarantee to be as above stated.

The labor I figured at \$7.50 per day including man's transportation, board and lodging while at work and \$3.00 per day for digging trench for pipe to carborator and making connections.
