A meeting of the Board of Trustees was called to meet at 12 o'clock at the Davenport Hotel. Those present, Mrs. Mary A. Monroe, Chairman, Mr. Chas. McLean, Mr. V. T. Tustin and Mr. Showalter. The question of awarding the contract for Monroe Hall was considered at length and it was thought wise under the circumstances to get a financial statement from the Secretary before making a final decision. Since Mrs. Monroe had all plans arranged for her California trip it was agreed that the other two members make the final award when a financial report was received.

Mrs. Monroe requested that all bills be audited and signed by Mr. McLean in her absence and expressed that if it were necessary at any time to have her official approval on any point she would be glad to have the matter sent to her. She gave as her official address, 9 Claremont Manor, Oakland, California.

The Board adjourned at 1:30 P. M.
