## BOARD OF TRUSTEES MEETING

The board of trustees met for supper and held a business meeting at the home of the chairman the evening of October 31st. The following matters were discussed:

Mrs. Fancy reported the result of her investi-Lamps: gation of the request for lamps for the girls' rooms at Monroe Hall. Two bids for table lamps were submitted; one by Brown and Johnson for \$3.00, 12" shades, \$1.25; one by Miss Jones, interior decorator, wrought iron table lamps, double socket \$3.00, 12" shades \$1.25, 16" shades The consensus of opinion was that the 16" shade \$1.50. is preferable. The action of the board favored the purchase of 46 of these lamps for the girls' rooms but it was felt that Mrs. Fancy should look into the needs of Senior Hall for lamps before any purchase was made.

Rugs: The request for 42 rugs, 6 x 9, for the girls' rooms in Monroe Hall was discussed. The report favored the Royal Wilton, 6 x 9, which Culbertson's quoted at It was suggested that no decision be made on \$45.00. the rugs, however, until a rug man whom Culbertson's was expecting in the second week of November is here with his line; then there will be an opportunity for the committee to make a better selection. Mrs. Fancy read a letter she received from Miss Goodman relative to the need for rugs for Senior Hall. It was decided to appoint Mrs. Fancy to look into the Senior Hall situation again before taking any final action on the number of rugs to be purchased. Miss Wilson reported that she had a bid from Gunderson's to make the old worn out rugs into 30 x 40 fluff rugs for the girls' bedrooms. Impression prevailed that it would be an economical thing to have these old rugs converted into something useable in this way.

Mr. Hargreaves reported on the repairs to the swimming pool and also submitted a request for the installation of a urinal in the boys' locker room. He was asked to get bids on this installation.

The question of continuing Miss Goodman as director of Senior Hall was up for consideration. The board was agreed that the school was paying entirely too much for the position. It was suggested that in as much as she is entitled to a quarter's leave it would be advisable to pay her for the next quarter and release her.

Meeting adjourned. (October 31, 1926)
