BOARD OF TRUSTEES MEETING

The trustees met for dinner at the Davenport Hotel Wednesday evening, December 8th. After dinner they adjourned to the mezzanine floor for a business meeting.

Halls of Residence: The purchase of the following was approved: 46 Wilton rugs 6 x 9 at \$50.00 each, less 10% discount, \$2070.00; 160 rugs 27 x 48 at \$3.20 each \$512.00 (to be made from worn out rugs); 76 wrought iron lamps with parchment shades at \$4.50 each, \$342.00.

Radiators: The bid of the Cheney Plumbing and Heating Company to install four radiators in the trunk rooms at Senior Hall at a cost of \$191.90 was accepted and ordered installed.

Refrigeration: The matter of installing the Frigidaire system in Monroe Hall kitchen was brought up. A bid of \$856.00 was received from the P. F. Pickette Company. It was voted to have Miss Wilson ask the manufacturer of the Kelvinator to submit a bid; also the Washington Water Power to submit a bid on their machine the Electro-Kold. No action was taken.

Dining Hall: The board favored the building of a dining hall this year and agreed that it would be well to ask Mr. Zittel to proceed to draw plans. The building will be financed through the selling of bonds.

Improvements to Grounds: It was suggested that Mr. Duncan of the park board be called in to consult with the school on the improvement of the newly acquired property.

Directory: It was voted not to place an add in the Polk Company County Directory.

Miss Goodman: After some discussion the president was instructed to dismiss Miss Goodman December 17th; granting her a quarter's leave of absence on pay.

Some time was spent discussing matters to be brought up at the legislative luncheon Thursday, December 9th.
