BOARD OF TRUSTEES MEETING

The Board of Trustees met in the Davenport Hotel Tuesday evening, March 26, 1931, at 6:30 P.M. Present: Mr. Lund, Chairman, Mr. Munter, Mrs. Fancy, Mr. Hargreaves and Mr. Stronach.

The minutes of the meeting for January 20th were read and approved.

CHENEY BOARD: Mr. Hargreaves reported that the Cheney Board of School Directors requested a joint meeting with the Normal School Trustees for Thursday evening, April 2nd, at 6:30 in the high school building. The matter of giving them a definite answer was deferred until Monday, March 30th, in order to find out whether or not Mr. Lund could attend on that date. If not, it was suggested that the Cheney Board be asked to change their date until Friday, April 3rd.

BUDGET: Mr. Hargreaves submitted the following report on the budget passed by the 1931 Legislature and approved by the Governor:

From the Cheney Normal School Fund:

Salaries and wages.....	\$369,378.00

This budget is \$35,659.00 less than we received for the 1929-31 biennium and \$60,540.00 less than requested for the present biennium. The cut of \$35,659.00 over the budget for the preceding biennium made necessary a rearrangement and revision of the salary situation.

Mr. Hargreaves submitted and recommended the adoption of the following plan:

That the associated fees for the four quarters shall be kept as one account.

To increase the associated fee \$2.00 per quarter.

BUDGET: (Continued)

The \$14,400 received from these additional fees and the \$12,000 saved by dropping people together with the \$5,800 transferred from State to Local Funds (\$32,200.00 plus \$369,378.00 equals \$401,578.00) will make it possible to operate without cutting salaries.

After an extended discussion, on motion of Mr. Munter, seconded by Mrs. Fancy, the above plan submitted by Mr. Hargreaves was unanimously approved with the provision that the associated fee be increased from \$7.00 to \$10.00, \$1.00 of which is to go to the health fund and \$2.00 to the activities fund. During the discussion it was pointed out by both Mr. Hargreaves and Mr. Stronach that this associated fee of \$10.00 still leaves our fees lower than the fees of either of the other Normal Schools of the state.

PUMP: Mr. Hargreaves reported that the present pump is worn out and had to be pulled last week and temporarily repaired; that it should be replaced with a new one immediately so that we may have an adequate supply of water for sprinkling purposes before the warm weather starts. Mr. Stronach on being questioned said that he had had some experience with pumps and had been investigating the available eight-inch pumps. He expressed himself as favoring the Sterling pump not only because it is one of the best but because it is handled by the General Machinery Company, of Spokane, and can be locally serviced. The matter of deciding on the pump to be purchased and installed was left to Mr. Munter and Mr. Stronach.

MONROE HALL: The Board voted to purchase (on the recommendation of Mrs. Fancy) two davenport for Monroe Hall from the Barrett Manufacturing Company, the two to be delivered by truck at the Normal School for \$390.
