MEETING OF THE BOARD OF TRUSTEES

The Board of Trustees met in the Davenport Hotel at 6:30, Friday, March 31st. Present: Richard S. Munter; Joel E. Ferris; James P. Dillard and R. T. Hargreaves.

The minutes of the last meeting were read and approved.

Mr. Hargreaves read a copy of the letter which he sent to the Governor, at the suggestion of the Board, reflecting its point of view in regard to the provision in the Appropriation Bill limiting expenditures to "revenues actually on hand." He then read the Governor's reply.

SALARIES Mr. Hargreaves submitted a list of the faculty and other employees on the State pay roll, together with the 1931 salary of each, and also the salary of each on the basis of a 25% reduction, copies of which are attached. After reviewing each item in this list separately, on motion of Mr. Dillard, seconded by Mr. Ferris, a general reduction of 25% on all salaries in the list was unanimously approved. Mr. Hargreaves then submitted a list of the 1931 salaries of all the employees who are paid out of local funds, a copy of which is herewith attached. The reductions proposed for the people on this list were unanimously approved.

LEAVES OF ABSENCE It was the opinion of the Board that leaves of absence on pay should be suspended for 1933-1934. The motion that prevailed read as follows: "Faculty members shall be granted leaves of absence, without pay, during the year 1933-1934, or any quarter thereof, and not otherwise."

The meeting adjourned at 11:05.
