## MEETING OF THE BOARD OF TRUSTEES

The Board of Trustees met for luncheon at the Davenport Hotel Wednesday November 22nd, 1933 at 12:15.

Present: Mr. Richard S. Munter, Mr. James P. Dillard, Mr. Joel E. Ferris, and Mr. R. T. Hargreaves.

The minutes of the last meeting were read and approved.

INSURANCE: The matter of placing a blanket insurance policy on the Normal School buildings was discussed. It was the concensus of opinion that under existing circumstances the school should be protected against loss because of the impossibility of getting funds from the State for replacement of any building that might burn. Mr. Hargreaves was, therefore, instructed to have policies for a 90% blanket coverage prepared to be submitted to the Board at an early meeting.

STUDENT COST: Mr. Hargreaves reported that the University of Washington students in their campaign for increased funds for the University had published figures of per capita cost to the State for each of the five higher institutions. The aim of the publication of these figures apparently was to make a good case for the University. According to the University Daily the per capita cost of Cheney Normal to the State is the highest of any of the institutions, \$450.00. Whereas the cost based on actual expenditures for the biennium to date is \$227.00. The University students figures on the Normal School's cost included board and room and all local cash funds, both of which are a charge against the individual student and not against the state.

TRAINING SCHOOL: Sometime was devoted to a discussion of the possibility of securing in some way a portion of the money that the Federal Government or the State or both are spending for unemployment relief for the construction of buildings. The Board asked to have a report on the dining hall and dormitory costs and receipts for last year and suggested that the President and business office make a study of it and see whether or not there might be any funds that could be pledged in order to secure an allocation of funds from Federal or State sources or both.

The meeting adjourned at 1:20 P.M..
