MINUTES OF THE BOARD OF TRUSTEES

The Board of Trustees of Eastern Washington College of Education met at 12:00 noon, February 2, 1945, in the Davenport Hotel at Spokane, Washington. Present Mr. Richard S. Munter, chairman, Mr. Joel E. Ferris, and President Ralph E. Tieje.

LEAVES OF ABSENCE Dean Nelson requested that her leave of absence for the summer quarter 1945 be cancelled, and the following periods of leave with salary be allowed: January 8 to February 19, and July 2 to August 10. The request was approved.

The request of Miss Mary Swerer for leave of absence with salary during the second half of the summer quarter was disapproved since it was deemed inadvisable to establish a policy of granting such leaves out of turn.

<u>APPOINTMENTS</u> The Board approved the following assignments to the staff:

Mrs. Grier to be first cook at \$130.00 per month, beginning January 1, 1945.

Mrs. Wick to be second cook in the Monroe Dining Hall at \$100.00 per month, beginning Tuesday, January 23, 1945.

Mr. Earl D. Reed to be employed in the heating plant at \$125.00 per month, beginning January 25, 1945.
