MINUTES OF BOARD OF TRUSTEES MEETING Friday, January 16, 1970 Marigold Room, Tawanka Commons E.W.S.C. Cheney, Washington

The Board of Trustees of Eastern Washington State College held a business meeting on Friday evening, January 16, 1970, in the Marigold Room of Tawanka Commons, E.W.S.C., Cheney, Washington. The meeting was called to order at 6:40 p.m. by Chairman L. G. Carmody. The following were present:

PENDING CLENCHED FIST ISSUE

Chairman Carmody announced that the Board of Trustees held an advance meeting at 5:15 p.m., January 16, 1970, with Mr. Robert Lamp, Assistant Attorney General, to discuss the pending lawsuit in reference to the litigation in which the Board and others are named as defendants.

MINUTES

The minutes of the December 16, 1969, Board of Trustees meeting were approved upon a motion by Mrs. Wilson with a second by Mr. Meagher.

PRESIDENTS' REPORTS

President Shuck reported to the Board on a number of information and pending items.

A.S.B. President Bob VanSchoorl reported to the Board on a number of items of interest concerning student activities on the E.W.S.C. campus.

Alumni President Robert Lincoln also reported on the current survey being conducted among alumni of E.W.S.C., and their proposed sponsorship of study meetings centered upon environmental control problems.

PERSONNEL ACTIONS

Mr. Meagher moved and Mr. Haffner seconded the motion that all recommended personnel actions, including the addition of Wilford E. Martyn, M.D., as a Consultant in Psychology in the Department of Psychology, be approved by the Board. This motion was passed.

BIDS FOR THE CONSTRUCTION OF PHASE II, CREATIVE ARTS CENTER

After much discussion, a motion was made by Mr. Meagher requesting that the Board not consider any bids that would further obligate the College under the existing economic conditions. Mr. Haffner seconded this motion, but the motion was not acted upon. The motion was then amended to read that any consideration of the bids from Phase II, Creative Arts Center, be tabled. Mr. Haffner seconded this motion. The amended motion to table the recommendations for Agenda Item IV-A-1 was passed.

Miss Nelson moved that a request be made for an appropriation from the 1970 special session of the Legislature in the amount of \$415,000 for tuition funds which would allow for awarding contracts on Phase II, Creative Arts Center, if this is the later decision of the Board. Mr. Meagher seconded this motion, and it was passed.

EXEMPTIONS FROM CIVIL SERVICE COVERAGE

Mr. Meagher moved for acceptance of Rule 251-04-040 of the Higher Education Personnel Board, describing those classes of positions which are exempt by law from Civil Service status, and those which may be exempted by action of the governing board of each institution. Mr. Haffner seconded this motion, and it was passed.

ESTABLISHMENT OF E.W.S.C. DEVELOPMENT FUND

Mrs. Wilson moved for the acceptance of action establishing an Eastern Washington State College Development Fund, into which unrestricted gifts and bequests could be deposited. The principal of the fund would be invested at the direction of the Board of Trustees, and the annual investment income would be allocated by the Board. Mr. Meagher seconded this motion, and it was passed.

Chairman Carmody and Miss Nelson left the Board meeting at approximately 8:20 p.m. to return to Seattle. Vice-Chairman Mary Wilson then took the chair.

FEE INCREASE FOR SUMMER QUARTER 1970

Mr. Haffner moved to act upon the section of summer fee recommendation regarding full-fee paying-students with an increase in tuition from \$88 to \$110, effective the summer quarter 1970. Mr. Meagher seconded this motion, and it was passed.

NEW BUSINESS

Mr. Haffner moved that the Board of Trustees request appointment of Special Counsel for the E.W.S.C. coaches in the pending lawsuit on the clenched fist issue. Mr. Meagher seconded this motion, and it was passed.
