MINUTES OF BOARD OF TRUSTEES MEETING

Friday, March 20, 1970 Cougar Room, Ridpath Hotel Spokane, Washington

The Board of Trustees of Eastern Washington State College held a business meeting on Friday evening, March 20, 1970, in the Cougar Room, Ridpath Hotel, Spokane, Washington. The meeting was called to order at 6:35 p.m. by Acting Chairman Mrs. Frederick Wilson. The following were present:

MINUTES

Mr. Haffner moved and Miss Nelson seconded approval of the February 13, February 20, and March 10, 1970, Board of Trustees Minutes. The motion was passed.

PRESIDENTS' REPORTS

President Shuck reported to the Board on a number of information and pending items.

Robert Lincoln, President of the Alumni Association, reported preliminary results from the questionnaires returned by alumni, and described the seminars on environmental quality being sponsored by the EWSC Alumni Association.

PERSONNEL ACTIONS

. Miss Nelson moved and Mr. Haffner seconded the motion that all recommended personnel actions be approved by the Board. The motion was passed.

AUTHORIZATION TO CONDUCT SECURITY TRANSACTIONS

Mr. Haffner moved and Miss Nelson seconded the motion to authorize the President, the Business Manager, and the Controller to conduct securities transactions on behalf of the College with member firms of the New York Stock Exchange with offices in Spokane. The motion was passed.

CAMPUS WATER AND TELEPHONE SYSTEM

Mr. Haffner moved and Miss Nelson seconded the concurrence by the Board of Trustees in the award of a contract for improvements to the campus water system, and for additional telephone ducts to service the campus telephone system. Bids will be opened April 3, 1970. The motion passed.

ARCHITECTURAL APPOINTMENT

After discussion concerning the recommendation for architectural appointment made by the project committee for the new multi-purpose classroom building, Mr. Haffner moved to table this item. There was no second to his motion. Miss Nelson moved and Mr. Haffner seconded the motion to accept Barnard & Holloway as the architects for the project. After a discussion on the procedure used to select and recommend architects, the motion was passed.

NAMING OF MUSIC BUILDING

Mr. Haffner moved and Miss Nelson seconded the Public Affairs Council recommendation to name the present Music Building for William Lloyd Rowles. The Council further recommended that should this building at some time in the future be razed, Mr. Rowles' name could be resubmitted for another building. The motion was passed.

TUITION AND FEE SCHEDULE FOR 1970-71

Mr. Haffner moved and Miss Nelson seconded the recommended tuition and fee schedule for 1970-71 with the following amendments: Under I. Recommendation, the wording was amended to read: "The following increases in tuition and fees for quarters other than summer are recommended, to become effective May 1, 1970. (First applicable to pre-registration for fall 1970 quarter)" Also Under I-C, the words "and Extension and Correspondence Fee" were deleted. The motion was passed.

AMENDMENTS TO COLLEGE PARKING REGULATIONS

The proposed amendments to the College Parking Regulations were moved by Miss Nelson, seconded by Mr. Haffner, and passed.

1970-71 ACADEMIC SALARY SCHEDULE

Mr. Haffner moved and Miss Nelson seconded a motion to approve the proposed 1970-71 Academic Salary Schedule. The motion was passed.
