MINUTES OF THE BOARD OF TRUSTEES MEETING

The Board of Trustees of Eastern Washington State College held a regular business meeting Friday, October 13, 1972, in the Morrison-Streeter Multi-Purpose Room on campus. The meeting was called to order at 1:40 p.m. by Vice Chairman Morris G. Shore.

MINUTES

Mr. Robinson moved that the minutes of the regular meeting of the Board held on September 15, 1972, be approved. Mrs. Wilson seconded; motion passed.

After approving the minutes of the meeting, Mr. Shore requested that the action items on the agenda be considered before the Presidents' reports because of the possibility of not having a quorum after 3:15 p.m.

PERSONNEL ACTIONS

Mr. Robinson moved that the Academic and the Administrative Personnel Actions, including addendum, be approved as submitted. Mrs. Wilson seconded the motion; motion passed.

CITY AND COLLEGE RECREATIONAL FACILITIES USE AGREEMENT

Mrs. Wilson moved to approve the Interlocal Cooperation Agreement among the Cheney School District, the City of Cheney, and the College covering the use of recreational facilities. Mr. Robinson seconded the motion; motion carried. This item had been tabled from the August 4, 1972, regular meeting of the Board.

BUILDING DEMOLITION CONTRACT

Mrs. Wilson moved to approve Contract No. 72-002, awarded on February 16, 1972, to Western Refuse Company for the demolition and removal of old houses. Mr. Robinson seconded the motion and motion passed.

MUSIC BUILDING HUMIDIFIER

Mrs. Wilson moved to approve the contract award to McClintock and Turk, Inc., in the amount of \$6,924, for a Music Building Humidification System. Mr. Robinson seconded the motion; motion carried.

COMPUTER CENTER AND RECEIVING WAREHOUSE BIDDING

The item authorizing the receiving of bids and awarding of contracts for Computer Center cooling and remodeling of the Receiving Warehouse restroom facilities was deferred, by a motion from Mrs. Wilson and seconded by Mr. Robinson, to a telephone vote at the time of the bid openings.

1973 STAFF VACATION SCHEDULE

Mrs. Wilson moved to accept the recommended staff vacation schedule to be designated as College holidays for the 1973 calendar year. Her motion lacked a second. Mr. Robinson then moved to table this item so that consideration could be given to designating the birth date of Martin Luther King on January 15 as a day of vacation. His motion was not seconded. Mr. Shore requested that the vacation schedule be placed on the agenda for the November Board of Trustees meeting.

DORMITORY VISITATION POLICY

Mr. Robinson moved to approve the policy change in the dormitory visitation hours allowing the residents of the individual dormitories to establish their own hours, by floor with a two-thirds majority vote of all residents each quarter. Mrs. Wilson seconded the motion and the motion carried. The change will become effective January 1, 1973. Mr. Shore requested that the Board of Trustees members be informed of the implementation date.

ACADEMIC REORGANIZATION

Mr. Robinson moved to accept the College Academic Reorganization as submitted to the Board by Dr. Philip Marshall, Vice President for Academic Affairs. Mrs. Wilson seconded; motion was passed.
