BUSINESS MEETING

Chairperson Robinson called the business meeting to order at 12:15 p.m. Wednesday, February 26, 1975.

MINUTES APPROVED

Motion #02-75-01: "That the minutes of the January 16, 1975, Board of Trustees meeting be approved."

Motion by Mr. Page, seconded by Mr. Haffner; approved unanimously.

APPOINTMENT OF DEPARTMENT CHAIRPERSONS

Motion #02-75-02: "That the selection process and term of appointment as adopted by the Board of Trustees on March 24, 1972 be reaffirmed. Department Chairpersons will be nominated by their respective faculties at a meeting or meetings conducted by their Dean. If a nominee is acceptable to the Dean he will then forward the name to the Vice President of Academic Affairs for submission to the Board of Trustees. The term of appointment will usually be for three years but the President may designate a lesser term in the case of initial or interim appointments."

Motion by Mr. Haffner, seconded by Mr. Page; approved unanimously.

SPECIAL EVENTS BUILDING LANDSCAPING IMPROVEMENTS

The Board of Trustees was unable to reach a decision on the award of the landscaping contract for the Special Events Building. Chairperson Robinson referred the matter for further study to the Board's committee on Budget. The Board's committee on Budget is to submit its recommendation for action by the full Board of Trustees in time for the March 20 meeting.

PLACEMENT FACILITIES POLICIES

Motion #02-75-03: Administrative Procedures Act Hearing. "That the Amendments to the Placement Facility Policies WAC 172-140 be approved."

Motion by Mr. Haffner, seconded by Mr. Page; approved unanimously.

FAMILY EDUCATIONAL RIGHTS AND PRIVACY ACT OF 1974

Motion #02-75-04: Administrative Procedures Act Hearing. "That WAC 172-08 for the Implementation of the Family Educational Rights and Privacy Act of 1974 be approved."

Motion by Mr. Haffner, seconded by Mr. Page; approved unanimously.

AMENDMENTS TO THE A.S. CONSTITUTION

Motion #02-75-05: "That the proposed Amendments to the A.S. Constitution in Article III, Section 4, Article IV, Section 2, and Article III, Section 7, Clause B be approved under emergency administrative procedures act rules and further that Article III, Section 7, Clause I be referred to the Budget Committee for further study and recommended disposition."

Motion by Mr. Haffner, seconded by Mr. Page; approved unanimously.
