## PRESIDENTS' REPORTS

Mr. Patrick Hayes, President of the Associated Students, reported on student activities.

Dr. Emerson Shuck, President of EWSC, reported on a number of College related subjects.

#### BOARD OF TRUSTEES COMMITTEE - AFFIRMATIVE ACTION

Speaking for the Board's committee on Affirmative Action Mr. Jerome W. Page Vice Chairperson, Board of Trustees reported on the progress to date in the development of a revised Affirmative Action Program for Eastern Washington State College. The plan in draft form prepared by Mr. D. Roger Reed, Assistant Attorney General, contains all the latest provisions on Affirmative Action and complies with all Federal and State Law, and will be distributed during the week of January 20 to the President of the Faculty Organization, the Council of Academic Deans, the Chairperson of the Faculty Affairs Council, the President of the Washington Federation of State Employees, President of the Associated Students, the Washington Human Rights Commission and the Higher Education Personnel Board. Each recipient of the draft will be asked to prepare written comments and forward them to the Secretary of the Board of Trustees.

On February 4 the Board's committee on Affirmative Action will hold an all-day meeting on campus with all interested parties.

On February 23, the final draft incorporating all the suggested changes accepted by the Board's committee will be presented by the committee at the February Board of Trustees meeting. The committee will again call for comments and give respondents ten days in which to submit written commentary on the Affirmative Action plan.

On March 20 an Administrative Procedures Act hearing will be conducted as part of the scheduled Board of Trustees meeting with final adoption of the plan at that time by the Board of Trustees.

# RESTAURANT FACILITY IN THE PENCE UNION BUILDING

Dr. Daryl Hagie, Vice President for Student Services, explained that the Board of Trustees approved the concept of establishing a tavern type facility in 1972. In 1973 a bid was awarded and an application made to the State Liquor Control Board for a license to operate such a facility, but that application was subsequently denied. Since then the concept of a tavern or beer garden has been modified, and instead a restaurant facility will be opened which, as a complement to food service, will serve beverages including beer and wine.

Dr. Hagie further explained that no tax dollars were used in the construction of the student union building, its remodeling, maintenance and upkeep, or will they be used in the operation of the proposed restaurant. The facility is supported solely by student fees. The College Administration is as concerned with the difficult societal problems of alcoholism and drug abuse, but does not feel that Board of Trustees Meeting

operate -3establishing the restaurant facility will in any way exacerbate these problems. The contract to award the facility has been awarded by the College to Billings, Bros. Inc., of Spokane, whose owners, Bob and Bill Billings, are local businessmen and were selected after careful consideration. The Administration remains confident in their ability to operate a successful and responsible facility on our campus.


