Mr. Geraghty called the business meeting to order at 9:10 a.m. A quorum was established with all board members present.

### Reports

### Board of Trustees - Mrs. Beschel

Board members Beschel and Kirschbaum attended a national conference sponsored by the Association of Governing Boards in Washington, DC, in March. Notes from the conference will be sent to board members.

Eastern Washington University was well represented at the YWCA Leadership Luncheon in Spokane on February 26.

The Finance Committee held a meeting on March 24 and reviewed architecture and engineering selection procedures. The new procedures clarify requirements for business enterprises and overall affirmative action requirements.

Mr. Geraghty, on behalf of the board, expressed appreciation to Ms. Zenner for her service as president of the ASEWU. Ms. Zenner was presented gifts from the board and the faculty.

Mr. Jackson reported on President Schilt's visit to the Tri-Cities. Many education, business and alumni leaders were contacted in the area.

### University President - Dr. Schilt

Mr. Paul Redmond, CEO, COB and president of Washington Water Power, has agreed to be the 1988 Commencement Speaker. Redmond has been CEO of WWP for six years. He serves on many community and civic boards in the Spokane area including Momentum '88.

The Northwest Association of Schools and Colleges conducted its on-site accreditation review. The team complimented Eastern on the quality of its faculty, students, campus appearance and the quality of preparation for the visit. Board members will receive a summary of the visit.

### Faculty Organization - Dr. Ramo

The forum on athletics went well. The senate recently passed a resolution supporting a Phi Beta Kappa Chapter on campus and endorsed the EWU 2000 role and mission statement. The senate is reviewing a policy on telecommunications instruction, which has been reviewed through the council structure. The Faculty Affairs Council is developing a policy for complimentary textbooks. Planning priorities were passed by the senate (see attachment I.).

### Associated Students - Mr. Belden

The spring leadership retreat was held and goals were set. Board members are encouraged to attend any ASEWU sponsored activities. (See attachment to the 4/21/88 agenda for full report.)

### EWU Spokane - Educational Plans - President's Planning Council

### Dr. Thompson:

The planning council generally supports the content of the draft report, describing the relationship of the university to Spokane and Cheney. A discussion draft was forwarded to student leadership. The facilities issue is unresolved.

### Dr. Schilt:

There has not been any interaction between the planning council and the community and other higher education constituencies, because the council wanted to present the report to the board for comment prior to asking for external comments. When the board has approved its direction, a draft will be shared with advisory groups.

### Mr. Ormsby:

Regarding facilities needs, the report should address faculty concerns about office space where they may meet with students, as well as the concerns of others, have indicated a need for a bookstore. The report should also include a better definition of library services and should articulate the need for capital support.

### Mr. Geraghty:

The plan should include what we are currently spending for services in Spokane as well as the expense of what we are proposing.

#### Mr. Hartman:

One hundred thousand square feet are being requested. The request and supportive material must be ready for the biennial budget submission in July. [However, in 5/88's report, 200,000 total square feet (125,000 assignable square feet) are being requested.]

Consultants may be brought in to determine such things as square footage and cost per student.

#### Mrs. Beschel:

Consolidation of our educational offerings into basically one location should be pursued because of the benefits to students and the economy in delivering support services. There could be exceptions because of unused course content, but the locational goal for the majority of classes is one site.

### Mr. Geraghty:

Consolidation should be considered wherever possible.

Motion #04-01-88: "I move that the board support the concepts embodied in the plan for educational service in Spokane by the President's Planning Council."

Motion by Mr. Ormsby; seconded by Mrs. Beschel; approved unanimously.

Between now and the May board of trustees meeting, the council should seek more input and feedback ideas and responses from the community including Spokane leadership, faculty, staff and student groups. Thought should be given to consolidation of services in one location, and costs of services and facilities should be estimated.

### Spokane Intercollegiate Research and Technology Institute - Dr. Schilt

The SIRTI is a cooperative effort of Eastern, Gonzaga, the Community Colleges of Spokane and WSU. It is an attempt to improve service and technology education in Spokane. In addition, it is hoped that close interaction with industry will "spin off" new products and develop new industries in Spokane.

### Dr. Ramo:

The faculty will not support the institute if additional funding isn't allocated and current resources must be stretched to accommodate it.

Motion #04-02-88: I move that the board approve the concept of the Spokane Intercollegiate Research and Technology Institute and Eastern's participation in the institute."

Motion by Mrs. Beschel; seconded by Mrs. Chase; approved unanimously.

### 1989 Operating Budget - Mr. Hartman

Preparation of the operating budget for 1988-89 is nearly finished. To balance the academic affairs budget, significant resources have been shifted from non-academic to academic areas. Non-academic areas will have to operate during this biennium with no increases in budget.

We are beginning to develop the budget for the 1989-91 biennium. Fortunately, the Office of Financial Management has simplified the budget process.

#### Action Items

### Minutes of February 18, 1988

Motion #04-03-88: "I move that the minutes of February 18, 1988, be approved as corrected."

Motion by Mr. Kirschbaum; seconded by Mr. Ormsby; approved unanimously.

### Roof Replacement - Public Works Contract - Mr. Hartman

The roof replacement is a multi-biennium capital project of approximately \$700,000. It includes roof replacements for Monroe, Senior, Sutton, Anderson and Showalter Halls, and the art and speech buildings in the fine arts complex. Dryden Hall will be included by change order if funds are available. Krueger Sheet Metal Company is the lowest responsible bidder on the project and has an acceptable MWBE participation rate and minority employment record.

Mr. Ormsby abstained from participation as his law firm represents the bidder.

Motion #04-04-88: "I move that we award contract #AE-85-02 to Krueger Sheet Metal Company of Spokane in the amount of \$700,000."

Motion by Mrs. Beschel; seconded by Mr. Jackson; approved unanimously.

### Electrical System - Public Works Contract Recision - Mr. Hartman

At the February meeting, the trustees accepted the bid from Sun Environmental for the electrical system renewal capital project. This work includes the replacement, transportation and destruction of PCB transformers. Sun Environmental has declined to execute the contract due to their inability to conform with formal bid specifications, their estimating errors and the availability of subcontractors.

We are retaining Sun Environmental's bid bond to cover the cost of any damage claims.

Upon advice of counsel, no action was taken on the recommendation to rescind this contract.

### Electrical System - Public Works Contract Award - Mr. Hartman

Motion #04-05-88: "I move that UNISON Corporation be awarded the contract for electrical system improvements, contract #AE-85-01."

Motion by Mr. Ormsby; seconded by Ms. Bannai; approved unanimously.

Final award of this contract will be contingent upon the recommendation of the attorney general.

### Selection of Hearing Examiner and Approval of Fee Schedule - Mr. Geraghty

In response to a grievance filed by Lawrence Kraft, and in accordance with university by-laws, the chair of the senate has submitted three names for the board of trustees' consideration.

Motion #04-06-88: "I move that Dr. Henry-York Steiner be appointed as hearing examiner for the Lawrence Kraft grievance."

Motion by Mr. Ormsby; seconded by Mrs. Chase; approved unanimously.

Motion #04-07-88: "I move that the proposed fee schedule as noted in attachment IV.F. be approved as presented." (See attachment IV.)

Motion by Mr. Jackson; seconded by Mr. Ormsby; approved unanimously.

### Mr. Hartman:

Costs are borne equally by the university and the grievant. Under usual university procedures, academic affairs will be

required to cover the university's costs. Mr. Kraft will be billed for his portion of the costs.

### <u>Veteran's Tuition and Fee Waiver - Dr. Borelli</u>

Mr. Grant:

Revised Code of Washington (RCW) 28B.35.361 authorizes boards of trustees to exempt from the payment of tuition and fees (except for individual instruction fees) any veterans who have served honorably during periods of war, provided that they have exhausted all other federal benefits and that they were enrolled in a regional institution of higher education on or before October 1, 1977.

Except for CWU, our sister institutions all offer the waiver. Their experience has been that less than ten students will be eligible for the waiver program.

Motion #04-08-88: "I move that the veteran's tuition and fee waiver be approved."

Motion by Mr. Kirschbaum; seconded by Mrs. Beschel; approved unanimously.

### Transcript Fee - Dr. Borelli

Under the proposed transcript fee policy, students would receive two free official transcripts at the time of graduation, but would be assessed three dollars for each additional official transcript; unofficial transcripts for on-campus use would continue to be provided to departments for advising purposes without charge.

Motion #04-09-88: "I move that the board authorize a three dollar fee for all official transcripts."

Motion by Mr. Ormsby; seconded by Mr. Jackson; approved unanimously.

### Amendments to Associated Students Constitution - Dr. Borelli

The changes to the associated students constitution will result in one associated students general election per year. During the 1988 winter quarter general elections, the students overwhelmingly approved the change.

Motion 04-10-88: "I move that the board ratify the students' action to hold one election per year."

Motion by Mrs. Beschel; seconded by Mr. Ormsby; approved unanimously.

### Delegation of Authority to Approve Changes in Associated Students Constitution - Dr. Borelli

It was recommended that the board delegate to the president of the university the authority to implement changes to the associated students constitution. The process by which changes are made would remain as it is; but, instead of submitting the proposed changes to the trustees, the president would act on them. Student leadership is in support of the proposal.

Motion #04-11-88: "I move that the board delegate the authority to approve changes in the associated students constitution to the president."

Motion by Mrs. Beschel; seconded by Ms. Bannai; approved unanimously.

#### Information Items

### Grants and Contracts - Dr. Beukema

The university's grants and contracts figures are higher at EWU than what is found nationally; this is a result of faculty efforts. A long term goal is to increase the number of faculty involved in grant writing and research and, in turn, increase the number of proposals.

### Trustee Old and New Business

Mrs. Beschel:

The proposed presidential evaluation procedure calls for an annual workshop to determine if the university is making progress toward reaching its adopted goals. Every third year, it will include an evaluation of the president.

Motion #04-12-88: I move that the board adopt the presidential evaluation procedure as drafted March 10, 1988. (See attachment V.)

Motion by Mrs. Beschel; seconded by Mr. Jackson; approved unanimously.

### **Executive Session**

The board held an executive session from 12:45 to 2:20 p.m.

### Personnel Actions

Motion #04-13-88: "I move that the personnel actions be approved as amended." (See attachment VI.)

### Faculty Planning Priorities

The Senate Rules Committee has condensed the planning priorities identified through various planning exercises to the list that follows. The principles that must guide implementation of these priorities are, first, that high quality education should be the overarching goal of all campus budget decisions; second, that decisions must be made through the process of shared governance; and third, that climate of cultural and intellectual stimulation and excellence should be fostered through extracurricular as well as curricular activities. Given these principles, Rules submits the following prioritized list.

The planning process should result in a plan which

- insures that faculty salaries and benefits at least match those at equivalent institutions and that annual salary increases automatically include a step plus an adjustment for cost of living (Merit pay should not be considered until these requirements are met. This means that merit pay should be on top of a decent salary schedule, not in place of one);
- insures that instructional equipment is replaced and upgraded on a routine basis and that adequate supply and instructional support budgets are maintained;
- 3. maximizes information storage, transfer and retrieval capabilities. (Needs, including those related to the library and to computing, must first be identified and prioritized to ensure an optimum return on investments);
- provides for continual faculty development (For example, fully funded attendance at conferences, workshops and professional meetings and released time for updating courses);
- 5. provides for an orderly replacement of retiring faculty that meets the needs of programs and departments. (The average age of the faculty is presently 52, so many retirements are likely to occur during a relatively short period of time.) Salary savings should be recycled into faculty salaries to help accomplish priority #1;
- 6. enhances the recruitment and retention of students. (basic skills courses should be supported.)

# Presidential Evaluation Procedure 3-10-88 (As Approved 4/21/88)

The board of trustees will informally evaluate the university during an annual workshop, tentatively scheduled for late spring. Workshops are open meetings and will provide an opportunity for constituent input. The focus of the workshop will be to assess the progress Eastern has made toward achieving its goals and whether the goals continue to be appropriate. Every third year, as part of this process, the trustees will include an evaluation of the president, based on his/her role in achieving these university goals and objectives. The evaluation of the president is a personnel matter. Therefore, the portion of the workshop devoted to the presidential evaluation will be in executive session.

The board will announce the scheduled evaluation of the president approximately one month before it is to occur. Various constituent groups will be advised of the evaluation.

The evaluation of the president will be based on his/her effectiveness in meeting university goals. The board will seek constituent input by conducting interviews with (specifically named) representatives of constituent groups and will consider all forms of input it receives during the evaluation period. (It may advise that the constituent groups follow the same procedure in soliciting and receiving information; i.e., through the interview process.) After the president has an opportunity to review and discuss the results of the evaluation with the board, the latter will report on the evaluation at a regular meeting of the board of trustees.

To facilitate the above process, the chair of the board of trustees may appoint a subcommittee of the board or select a consultant to gather constituent information for review with the president in private session.

(In addition, the president has indicated his desire to be accessible, on an on-going basis, to appropriate representatives of constituent groups.)

(The above draft concepts are based on recommendations from the Search consultant, Dr. Bruce Alton; AGB Reports; Dr. John W. Nason's <u>Presidential Assessment</u>; Dr. John Ryan, president emeritus, Indiana University; and from interviews and comments with EWU board members, the president and the faculty president.)
