The Grantors Cerhard E. Brede and Emma P. Brede, husband and wife of Spokane County of Spokane State of Washington for and in consideration of \$1.00 and other considerations Dollars, in hand paid, convey and warrant to Douglas A. Morrison, an unmarried man the following described real estate, situated in the County of Spokane State of Washington:

COMPARED Lots Five (5) and Six (6) in Block Ten (10) of Irving Heights Addition, in the City of Spokane, County of Spokane and State of Washington, as peremap thereof recorded in Book "A" of Plats, Page 103, in the office of the County Auditor of said County.

Subject to the provision that no residence shall be erected on any one lot at a cost of less than \$7500.00 and Subject to the covenant that this conveyance is made and accepted upon the condition that no race or nationality other than the white race shall use or occupy any building on the above described property except that this covenant shall not prevent occupancy by domestic servants of a different race or nationality employed by an owner or tenant.
