Lots Tem (10) and Twelve (12) im Block Fourteen (14): Lots Ome (1), Two (2), Three (3), Four (4) and Eight (8) in Block Twenty (20) (and Lots One (1), Two (2), Three (3), Four (4) and Five in the office of the County Auditor of said County.

Subject to 1946 taxes and the provision that no race or nationality other than the white race shall use or occupy any building on any lot, except that this covenant shall not prevent occupancy by domestic servants of a different race or nationality employed by an owner or tenant.
