STOLLE, husband and wife, 3 of Spokane, County of Spokane, State of Washington, for and in consideration ۵. of Four Thousand Dollars (\$4,000.00) in hand paid, convey and warrant to Б HENRY MALAND and GERTRUDE MALAND, husband and wife, the following described 6 real estate in the County of Spokane, State of Washington: 7 Lot Five (5) in Block Four (4) of ROCKWOOD PINES ADDITION in the 8 City of Spokane, County of Spokane and State of Washington, as per map thereof filed for record February 27, 1946, as Document No. 636548A, in the office of the County Auditor of said County. 9 10 The conveyance is made subject to the following protective and restrict-11 ive covenants which are and shall be common to all of said Rockwood Pines 12 13 Addition: 1. No structure shall be erected, altered, placed or permitted 14 to remain on said lot other than one detached single-family dwelling not to exceed two and one-half stories in height, and 15 a private garage for not more than three cars. Said dwelling shall be of modern style or architecture, and no trailer, 16 basement, tent, shack, garage or other out-building at any time shall be used as a residence, temporary or permanent, nor 17 shall any structure of a temporary character be used as a residence thereon. 18 2. No dwelling costing less than \$10,000.00 shall be permitted on 19 said lot. Such dwelling shall face as the street faces and shall not be located nearer than 35 feet to the front line of said lot. 20 Any garage which may be built on said property must conform to the style of architecture of the dwelling thereon. 21 3. No apartment house, tenement house, flat building, duplex, 22 lodging house or hotel shall be erected, altered or maintained upon said lot, nor shall any building constructed thereon be conducted or used for any of said purposes or for business 23 purposes of any kind. 24 4. No person of any race other than the Caucasian race shall 25 use or occupy any building or any part thereof on said lot, except that this covenant shall not prevent occupancy by domestic 26 servants of another race domiciled with an owner or tenant. 27 5. These covenants shall run with the land, shall be binding on the parties hereto and on all persons claiming under them. 28 6.00 6. If the parties hereto or any of them, or their heirs or 29 assigns, shall violate or attempt to violate any of the covenants herein, it shall be lawful for the other party and any other 30 person or persons owning any real property situated in said Rockwood Pines Addition to prosecute any proceedings at law or 31 in equity against the person or persons violating or attempting to violate any such covenant, either to prevent him or them from 32 so doing or to recover damages or other relief for such violations.
