Lot 27 in Block 1 of SUNSET VIEW ADDITION to the City of Spokane, County of Spokane and State of Washington,

Subject to the following restrictions governing Sunset View Addition:

Nothing but a single detached residence costing not less than \$5,000.00 with accompanying garage, shall be built on any one lot in said addition (save that as to Lots 1 to 18, inclusive, of Block 3 thereof such residence shall cost not less than \$6,000.00) and shall be used for residence purposes only. None of said lots shall be transferred to or occupied by other than persons of the Caucasian race until after October 15, 1980. Such restrictions shall inure to the benefit of the respective lot owners in said Sunset View Addition.
