THE GRANTORS, H. PHILLIPS LOWRY and BERNEICE W. LOWRY, husband and wife, of Spokane, County of Spokane, State of Washington, for and in consideration of One Thousand Dollars (\$1,000.00) in hand paid, convey and warrant to GEORGE E. WINKELS, husband of JUNE C. WINKELS, the following described real estate, situated in the County of Spokane, State of Washington:

Lots Twenty (20) and Twenty-one (21) in Block Two (2) of CITY VIEW ADDITION to Spokene Falls, now Spokene, according to the recorded plat thereof, subject to 1947 taxes.

This conveyance is made subject to the following protective and restrictive covenants which shall run with the land and be binding on the parties hereto and on all persons claiming under them:

- (1) Said lots shall be used for residential purposes only.
- (2) Any structure erected thereon shall comply with all of the building codes and regulations of the City of Spokane and of any agency thereof and shall cost not less than Four Thousand Five Hundred Dollars (\$4,500.00).
- (3) No person of any race other than the Caucasian race shall use or occupy any building or any part thereof on said lot, except that this covenant shall not prevent occupancy by domestic servants of another race domiciled with an owner or tenant.
- (4) These covenants may be enforced by the grantors or by any grantee, immediate or remote, of any property in said CITY VIEW ADDITION, or of ALBION HEIGHTS ADDITION to Spokane Falls, now Spokane, Spokane County, Washington, conveyed by grantors with similar covenants. Invalidation of any of said covenants by Court judgment or order shall in no wise affect any of the other of them, or any provisions thereof, which shall remain in full force and effect.
