George Cross: Motion, (withdrawn)

Lon Dale: By-law Review - Discussion of existing by-laws. By-laws can be changed but notice must be given to Board members prior to the change. Best to keep from getting the members involved. They aren't interested!

Lowell Hanson: Membership Report -

Motion by Lon Dale to have Earl Cooley as Honorary Director and Ed Courtney as President. Seconded by Jerry Timmons. MOTION CARRIED with Ed Courtney abstaining.

Ed Courtney reviewed proposals for up-coming year's work of the Association.
